違反條文

就業服務法第57條第8款
雇主不得非法扣留或侵佔所聘僱外國人之護照、居留證件或財物。

罰則

- 1.違反規定者處新臺幣6萬至30萬罰鍰
- 2.廢止其招募許可及聘僱許可。

Pelanggaran
Ketentuan

Peraturan layanan ketenagakerjaan pasal 57 ayat 8
Majikan tidak boleh melanggar hak kepemilikan atau menahan paspor, kartu ARC atau harta benda milik pekerja migran

Sanksi

1. Bagi pelanggar akan dikenakan sanksi denda antara NT\$ 60.000 – 300.000
2. Mencabut izin perekrutan awal dan izin mempekerjakan pekerja

A Friendly Reminder

Employers cannot confiscate or misappropriate the passport, alien resident certificate or property of foreign workers

Law violated

Paragraph 8, Article 57 of the Employment Service Act
Employers must not illegally confiscate or misappropriate the passport, alien resident certificate or property of any foreign worker under their employ

Penalties

1. Violations of this provision can result in a fine of NT\$60,000-NT\$300,000
2. Revocation of recruitment and employment permits

กฎหมายการจ้างงานมาตรา 57 ข้อ 8 ห้ามนายจ้างยึดหนังสือเดินทาง ใบถิ่นที่อยู่ (ARC) หรือยกยอกทรัพย์สินอื่นๆ ของแรงงานต่างชาติโดยมิชอบด้วยกฎหมาย

บทลงโทษ

1. ผู้ฝ่าฝืนต้องระวางโทษปรับ 60,000-300,000 TWD.
2. เพิกถอนใบอนุญาตนำเข้าและว่าจ้างแรงงานต่างชาติ

XIN NHẮC NHỞ!

Chủ sử dụng lao động không được cất giữ hoặc chiếm hữu tài sản, hộ chiếu và thẻ cư trú của người lao động.

Vi phạm điều lệ

Khoản 8, Điều 57 của Luật Dịch vụ việc làm:
Chủ thuê không được cất giữ hoặc chiếm hữu hộ chiếu, thẻ cư trú hoặc tài sản của lao động nước ngoài một cách bất hợp pháp.

Hình phạt

1. Người vi phạm sẽ bị phạt từ 60.000 đến 300.000 Đài tệ.
2. Thu hồi Giấy phép tuyển dụng và Giấy phép lao động.
